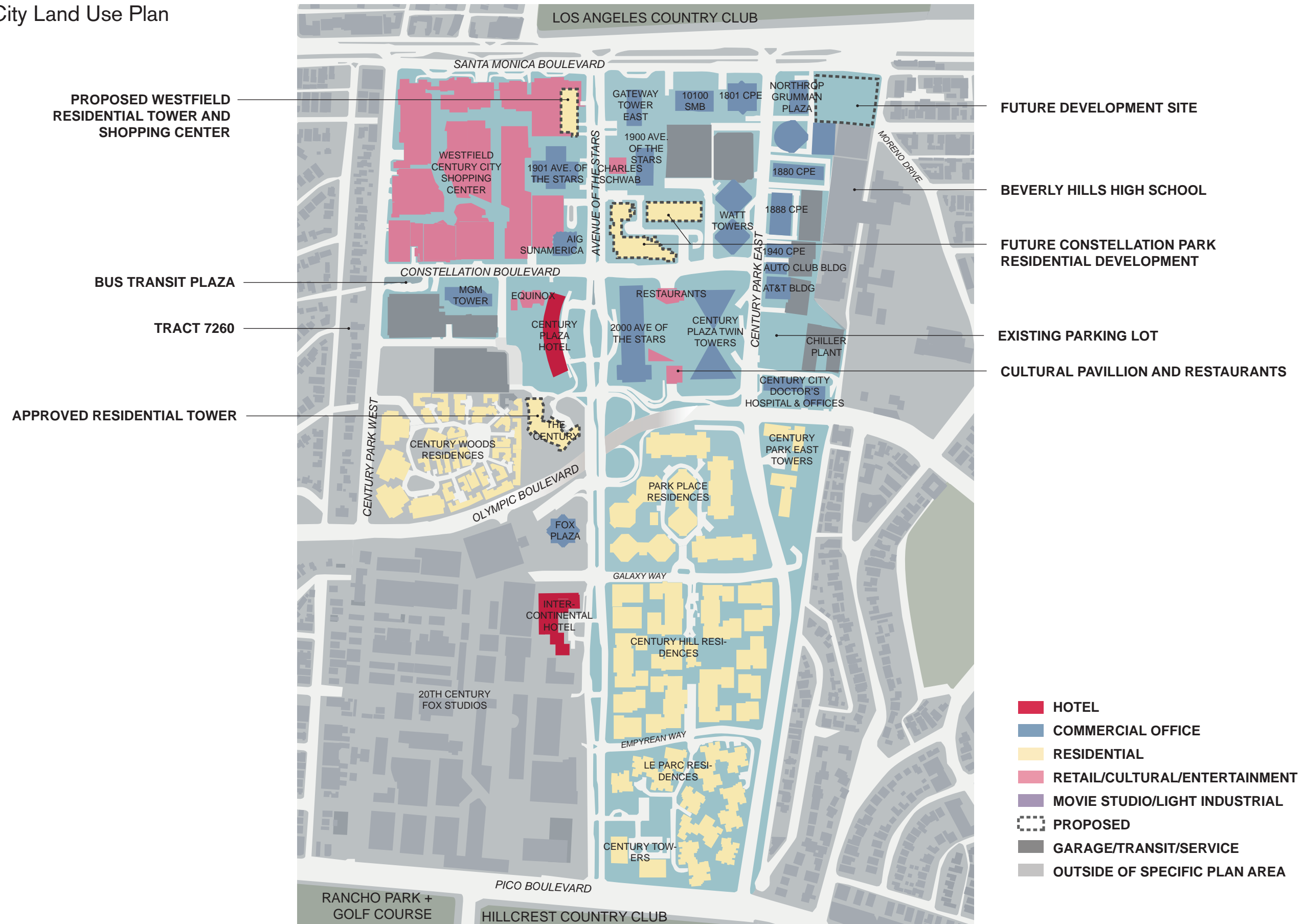
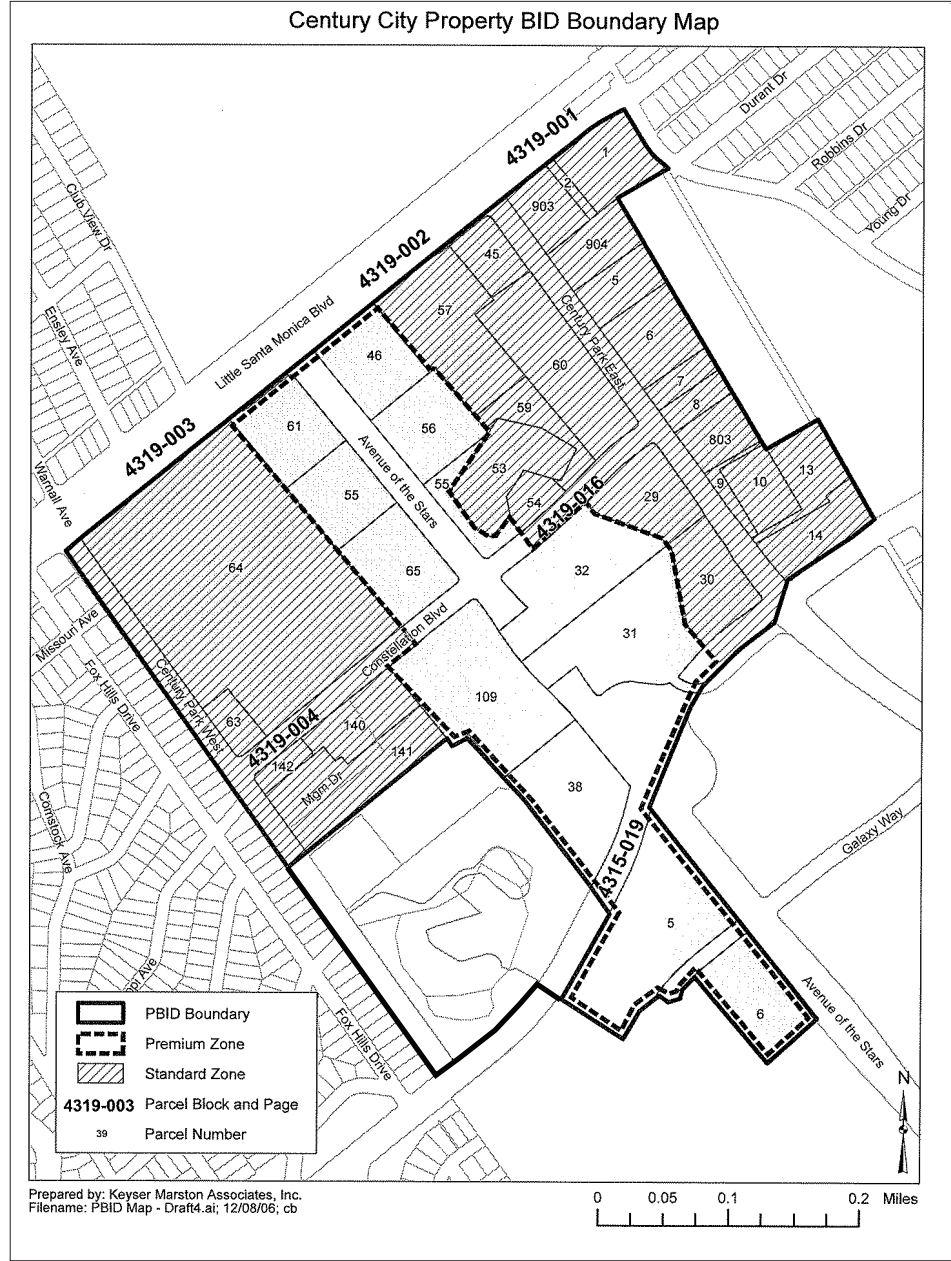

The proposed Century City Property Business Improvement District (PBID) will be an important entity integral to the longterm viability of the Greening of Century City Plan.

Developed by a coalition of property and business owners, the PBID will collaborate with the City to provide new services and activities above and beyond those currently provided by the City, such as sponsoring capital improvements, enhanced maintenance, and pedestrian security and safety.

- Capital improvements: replace aging irrigation, enhance landscape planting, install and maintain pedestrian amenities, contribute to refurbishment of the fountains on Avenue of the Stars.
- Enhanced maintenance: enhanced sidewalk sweeping and cleaning, graffiti and trash removal.
- Pedestrian security and safety: an "Ambassadors Guide" bike patrol to support law enforcement agencies in overall crime prevention while offering customer services such as directing pedestrians to civic, shopping and business destinations.
